4. Artwork must be rated “G” for all viewing ages.
5. Submitted artwork must be received by Seaside Vacations by 5:00 p.m. EST on Friday, September 30, 2011.
6. Submissions will not be returned to the entrant and become the sole and exclusive property of Seaside Vacations.
7. Electronic artwork must be saved at a high-resolution (minimum of 1800 x 1200 pixels in size) and in jpeg or PDF format. Electronic artwork must be submitted on a CD disk or a flash drive.
8. Please include the following information with your artwork: Entrant’s name; Entrant’s Address; City; State; Zip Code; Country; Entrant’s Phone Number; Entrant’s E-mail.
9. Designs are evaluated using the following factors:
 - a. Concept / Originality
 - b. Captures the spirit of the Outer Banks
 - c. Visibility – eye-catching and visible from a reasonable distance
