Before submitting a photo and/or video, be sure to read all the terms and conditions listed below. Since Seaside Vacations is a family oriented business, we reserve the right to reject unsuitable or inappropriate images.

### **Rules:**

1. All entries become the property of Seaside Vacations.
2. Submitted photo(s) must have been taken between January 1, 2009 and October 30, 2009 of an Outer Banks beach vacation. All photos and videos must accompany a signed and completed photographer's photo release, using the form available on our website. If the photographer is under 18 years of age, a parent or guardian of minor photographer must also sign the release form.
3. Photo(s) and video(s) may not contain business or trade names, whether in the background or foreground of the photo.
4. Photo(s) and video(s) may include people in the photo, but an executed model release for each pictured person must accompany the photo(s) and video(s), along with photographer's photo release, using the forms available on our website. Once again, if a model is under 18 years of age, the model's parent or guardian must also sign the release.
5. Photo(s) must be high-resolution digital color photo(s) at a minimum of 1800 x 1200 pixels in size and in jpeg format. Video(s) must be submitted in .wav format.
6. Photo(s) and video(s) must be rated "G" for all viewing ages.
7. Photos must be received by Seaside Vacations by 5:00 p.m. EST on October 30, 2009.
8. Photos must be submitted on a CD disk with a hard paper copy of each photo attached and the completed and signed release(s). Videos must be submitted on a DVD disk with completed and signed releases. Please complete forms for each photo submitted. Submissions, including all photo(s) and/or CD disks, will not be returned to the entrant and become the sole and exclusive property of Seaside Vacations.
9. Please tape to the back of each photo the following: Title of entry: Entrant's name: Entrant's Address, City, State, Zip code, Country; Entrant's Phone Number and email.
